The San Geronimo Valley Community Center Child Care, also known as Zoila's, accepts any school age children within the limits of the license for caring and supervision.

*The County is working on developing guidelines for safely providing our youth activity programs as part of its response to the COVID-19 emergency. As the San Geronimo Valley works to develop and operate its recreation programs in compliance with these guidelines, some programs may be restricted or cancelled.

The health and safety of our children and families is our greatest priority. We will clean and bandage cuts and scrapes. A quiet place to rest will be provided for a child who is not feeling well until a parent/guardian can be reached. All medications given must be in the original container and accompanied by a signed and dated note from the parent.

*When a child does show signs of illness, they will need to be picked up immediately.

*Schools and childcare facilities must adhere to required COVID-19 Case Reporting by Schools and notify the local health department of any newly reported case of COVID-19 in a student or staff member, if the local health department has not yet contacted them about the case.

*In the event of or at any time of exposure or confirmed case of Covid-19 Child Care facilities will close immediately and children must be picked up as soon as possible.

Indoor activities include: books and stories, playhouse area, large and small block building, games and puzzles, painting and art projects.

Outdoor activities include: playground with climbing structure, ball games and free play.

The majority of this program will be held outside, please have additional clothing available for your child.

Behavior expectations: Must be able to follow directions for the safety of themselves and others.

At this time, Children may NOT bring toys or books from home, but we are not responsible if they are lost or damaged.

Fees: Flat fee of \$25/ day. Scholarships and sliding scale fee is available. If you would like to sponsor another family please contact us. Families will have to commit to a three week session of childcare.

Please pick up your child promptly by 5:30pm
Late pickup will result in an additional fee of \$2 /minute

Drop-Off and Pick-Up: All children will be signed in and out by staff members.
Drop off: Students attending aftercare will be picked up by staff member and escorted to aftercare.

Pick Up: Parents and guardians will pick up outside and not enter aftercare facility and maintain six feet of social distancing at all times. Please notify staff member at pickup.

*Ideally, the same parent or designated person should drop off and pick up the child every day. Children will not be released to persons not listed on admissions application.

Please update forms whenever changes occur. Update emergency contact information regularly so site staff can get in touch quickly if they need to.
